## **INSTALLATION INSTRUCTIONS**

Note: This system can be installed with the installation tool provided. No other tools are necessary. Do not use power tools for installation. Phoenix™ recommends storing the tool with the vehicle's tire tool for future use.

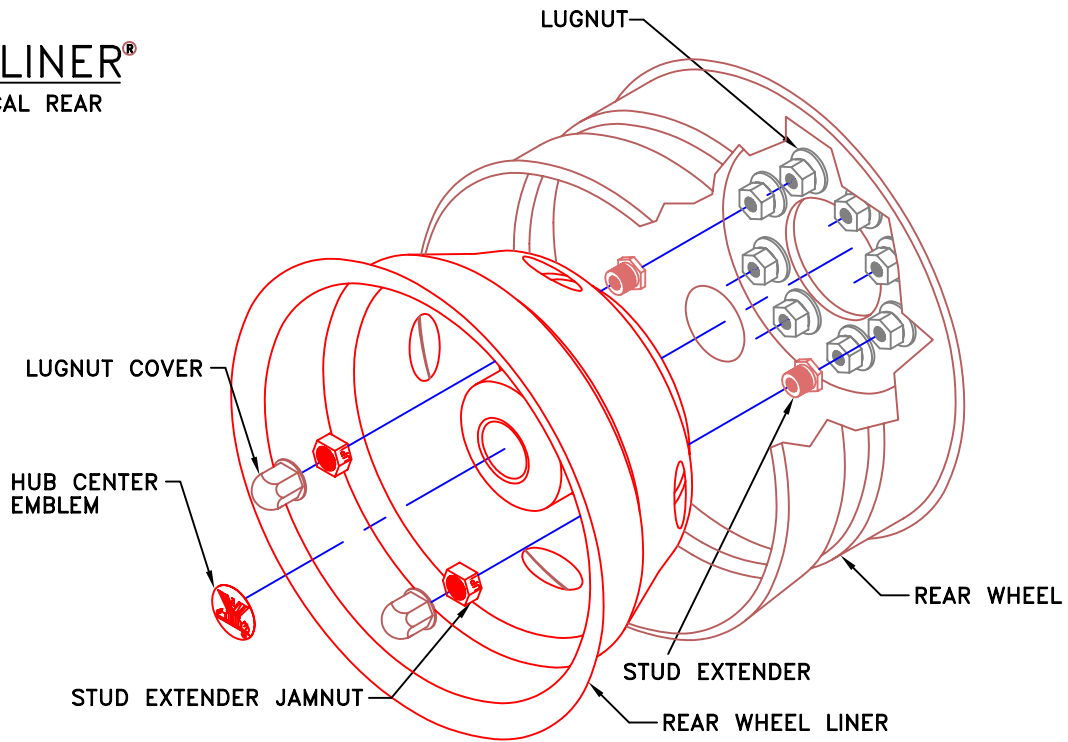
### **Assembly Drawings on Back**

1. Do not remove the original equipment lugnuts.
2. Determine correct placement of stud extenders required for proper hand hole alignment.
3. Install appropriate stud extender on the portion of the wheel studs that protrudes through the original equipment lug nut on opposing studs. Tighten stud extenders with included installation tool.
4. Install liner over stud extenders. Now, install the jam nuts on the stud extenders. Use the included tool to tighten the jam nuts.
5. Install the jam nut covers over the jam nuts.
6. Complete the wheel cover installation by applying hub center emblem.
7. Repeat steps 2 through 6 for the installation of the other wheel and axle covers.
